OLD BUSINESS:

Money has been reimbursed from unused portion Liability Insurance from Berends. Nothing yet from The Insurance Place for Workers' Comp.

Brownfield Grant – Project went over budget, but will still be reimbursed from DEQ.

Applegate Community Road Project costs came in at \$23,301, due to rain damage. The project will move forward.

A new PUD (Planned Unit Development) application was discussed, charge \$1000.00 fee, and 10 copies of site plan.

Discussion regarding Electronics Recycling Grant. Cannot be used as a single day recycling.

Discussion regarding Recycling Grant. Start looking at different options for recycling in our area. Grant option may be available next year and things will be in place. Short time span for this year with deadline being May 1.

Election Law Update – Conflicting information on different websites. New Registered Voters may register and vote the same day with proper identification. Clerk Sholty will have information on township website. For the May 7 Election, all Precinct 2 voters will vote at the Reynolds Township Hall for this election only.

Approve 2018-19 Library Amended Operating Budget. Motion by Sholty, 2nd by Eversole, Ayes: 5, Nays: 0, Motion Carried.
