Seal Coat w/Fog Seal Garbow Rd from Almy Rd to Edgar Rd. - \$19,668; Seal Coat w/Fog Seal Daggett Rd @ Little Muskegon River Bridge - \$9,620; Spray brush – shared project with Road Commission - \$2,000; 50 hours of Ditching Whitefish Rd - \$5,000; Asphalt overlay Amy School Rd from Almy Rd to Gates Rd. - \$55,298; Seal Coat w/Fog Seal Lake Montcalm Rd from Bass Lake Rd to Amy School Rd – split cost with Pierson Twp – (Reynolds \$10,817); and Seal Coat w/Fog Seal Lake Montcalm Rd from Amy School Rd to Federal Rd. – split cost with Pierson Twp – (Reynolds \$13,767.)
