

## REYNOLDS TOWNSHIP BOARD MEETING MINUTES

7.11.19

Supervisor Kindel called the regular Meeting of the Board to order at 7:00 pm., Pledge of Allegiance was given. Invocation given Pastor Gary Giddings, Church of the Full Gospel

MEMBERS PRESENT: Supervisor Kindel, Clerk Sholty, Treasurer Stedman, Trustee Eversole and Trustee Saucier.

CONSENT AGENDA: Deputy Schafer presented the Police Report and Mark Stevens Presented the Zoning Report.

Motion: Approve consent agenda consisting June 13, Regular Meeting of the Board Minutes, Police Report, Fire Report, Zoning Report, Treasurer's Report, Library Report and the Township's Monthly Bills. Motion by Saucier, 2<sup>nd</sup> by Sholty Ayes: 5, Nays: 0, Motion Carried.

### OLD BUSINESS:

Tax Account – Attorney John Schlinker presented the Board with a report of his findings. The report included a call log with BS & A, overdrawn tax account & fees, what township accounts were overpaid, delinquent tax turned over to the County that were actually paid, penalties & interest fees that were paid, and Michigan Law (MCL 41.77, Sec. 77) stating Treasurer is personally responsible.

Attorney Schlinker stated he cannot believe there was monies to pay the fees due to the overdrawn tax account, and stated he believes the account will be overdrawn again. Treasurer Stedman stated that was a possibility.

Clerk Sholty will check to see if a claim can be made on the Treasurer's bond, and will send an e-mail out to the Board when the request goes out and the response. The Township Board needs time to read through the report and a Special Meeting will be held on Monday, July 22, at 4:00 p.m. as to fees, penalties, interest and repayment.

Audit has been delayed due to Tax Account issues

Clean-up Day, 51.84 tons of trash collected \$2,488.32; 20.14 hrs. worked, \$4229.40, \$2,000 for tires. For a total of \$8,717.72 (after reimbursement money, approx. total of clean-up was \$5,000.)
