Motion: Table Planning Commission Correspondence regarding Masterplan. Motion by Eversole, 2<sup>nd</sup> by Stevens, Ayes: 5, Nays: 0, motion carried.

BOARD COMMENTS: Trustee Eversole gave update on Kass property. Several governmental agencies on board now and looking to get water and soil tested with expense possibly being distributed between EPA, DEQ & Mid-Michigan Health department. Trustee Eversole requested all information be made available to the public as it comes in from the various agencies.
