

REYNOLDS TOWNSHIP BOARD MEETING MINUTES

July 14, 2016

Clerk Sholty called the regular Meeting of the Board to order at 7:00 pm., Pledge of Allegiance was given. Invocation given by Pastor Dan Wolters, Pine Grove Community Church, Howard City.

MEMBERS PRESENT: Clerk Sholty, Trustee Eversole and Trustee Saucier. Absent: Supervisor Kindel, Treasurer Stevens.

PUBLIC COMMENT: Mr. Eric Smith, Montcalm County EMS informed the residents of the EMS Millage on the ballot and asking for support. Independent of Montcalm County General Fund monies, this is a renewal of the current millage and not an additional amount. Requesting the same levy of 0.75 mills but will only use what is needed (currently using .65 mills.) Mr. Smith also informed the residents of the "Vial of Life" program. Medical information put in a vial and stored in resident's cupboard, refrigerator, etc. with a "Vial of Life" sticker placed on the front of the vial location. This is a free program.

Gregory Alexander announced his candidacy for State Representative.

Also included in the festivities is the Chamber of Commerce Expo in the Park, Music in the Park and local craft vendors. Free hot dogs and sno cones, face painting and other options for kids.
